# **IMEQ CENTER - Terms and Conditions**

# 1. Introduction and Agreement to Terms

If a user wishes to have their data deleted prior to the end of the two-year period, they may submit a formal request to IMEQ CENTER. Upon verification of identity, the data will be deleted in accordance with applicable legal and regulatory requirements.

## 6. Use of Test Results

The results of any assessments conducted on the Platform are shared exclusively with the client who commissioned the test (e.g., the user's employer or designated organization). IMEQ CENTER does not disclose individual test results to any third parties unless required to do so by law or with the explicit consent of the user. Users should be aware that clients may use the test results for decision-making purposes related to employment or personal development.
